Course and membership fees

Beginners:

To make it easier to join Salisbury Canoe Club as a beginner we now providing our **Introduction to Paddlesport Courses** on Tuesday evenings. These will start each month with a taster session, generally around the beginning of the month (first taster is on the 30th April 2019). You will be in a coached group to get you paddling and enable you to progress through your British Canoeing Paddle Start and Discover Awards.

Your 1st year fee provides your club membership and recognises the increased coaching that you will receive. These fees are:

Child/student up to and including Yr 13:	£70
Adult:	£90
Family (3 members)	£220
Family (4 members)	£260
Family (5 or more)	£300
Taster session (no membership)	£5 per person
